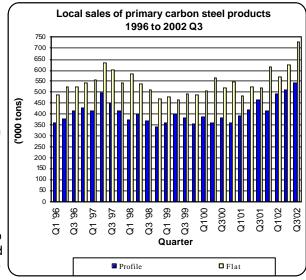
Domestic carbon steel sales growth accelerates during Q3 2002

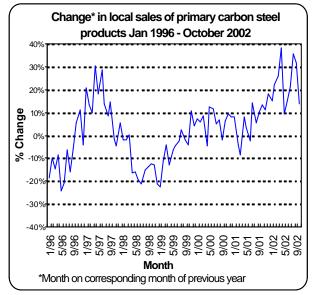
Total domestic carbon steel sales increased by 23,6% during the first 9 months of 2002 compared with the first 9 months of 2001. Compared with the first 9 months of 2001, sales of carbon steel long products increased by 20,5% while sales of flat products increased by 26,3% during the corresponding period. Domestic sales increased by 12,9% during the third quarter of 2002 compared with the second quarter of 2002. Profile product sales increased by 7,4% while sales of flat products increased by 17,3% during this period.

Clearer signs emerged that the global economy had reached a lower turning point, but so far the recovery has been somewhat tepid and not evenly distributed among the major industrial countries signifying that the recovery would not be as strong as had been anticipated earlier in 2002. Still, global economic activity is expected to gather momentum as the effects of the monetary easing and fiscal incentives permeate through the economies.

Apparently unperturbed by the uncertainties in the global economy the South African economy continued to expand well into 2002, but weaker global economic conditions caught up and the demand for South African exports declined during the third quarter of 2002. The slowdown in growth can be expected to carry over into 2003 and economic growth during 2003 could be on par with year-on-year growth of between 2,5% and 3% estimated for 2002.

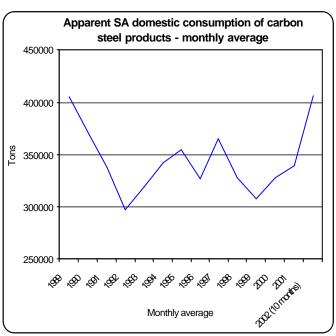

Imports of primary carbon steel products continue to decline into 2002

According to statistics released by Customs and Excise, imports of primary carbon steel products (excluding wire and stainless steel, but including rails) declined by 4,6% during the first 9 months of 2002 compared with the first 9 months of 2001. While imports of flat products declined by 18,9%, imports of profile products increased by

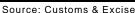
54,2% due to significant consignments of rail and semifinished product imports during the first 9 months of 2002 compared with the corresponding period of 2001.

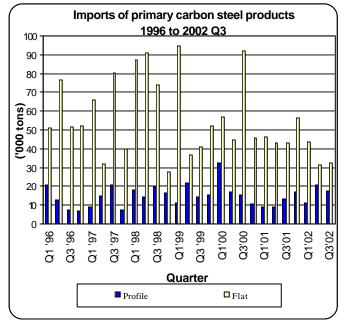
Imports of primary carbon steel products as a percentage of total domestic carbon steel demand declined to 4,3% during the first 9 months of 2002 compared with 5,9% during 2001 as a whole.

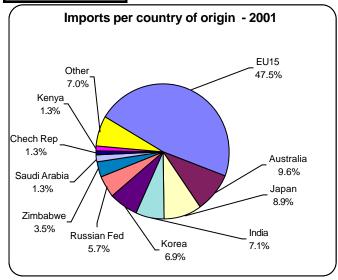

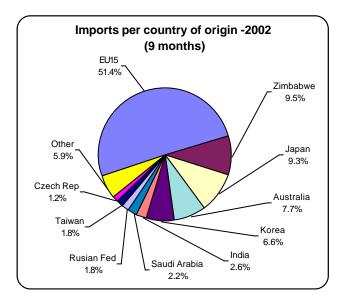

Imports of rails from Austria amounted to 13 300 tons, representing 94,2% of all rail imports during the first 9 months of 2002. Imports from Japan consisted mostly of alloy sheet products (39,6%) and of carbon galvanized sheet (33,3%). Imports of aluzinc sheet products amounted to 5 411 tons, mostly from Korea (47,6%) and Australia (30,4%).

Imports from Australia consisted mostly of painted sheet (70,8%) and represents 83,6% of the total of 11 753 tons of painted sheet imports during the first 9 months of 2002. Imports from Germany amounted to 30 095 tons and consists mostly of electro-galvanized and alloy sheet products. Imports from Korea consisted mostly of cold-rolled coils (35,5%) and of aluzinc sheet products (21,6%). Hot-dipped galvanised sheet imports from India amounted to 2 108 tons representing 18,3% of all imports of hot-dipped galvanised sheet imports.







Exports of carbon steel products as reported by South African producers increased during Q3 of 2002 over Q2 of 2002

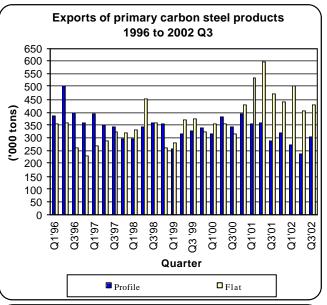
Exports of primary carbon steel products, reported by South African manufacturers, during the third quarter of 2002 increased by 12,4% compared with the second quarter of 2002. During the third quarter of 2002, exports of flat products increased by 6,4% compared with the second quarter of 2002 while exports of profile products showed an increase of 22,1% during the corresponding period. However, exports showed a decrease of 16,6% during the first 9 months of 2002 compared with the first 9 months of 2001.

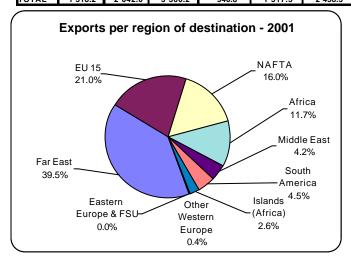
During the first 9 months of 2002, exports of flat steel products amounted to 61,8% of total exports and the exports of profile products to 38,2% of total exports. (continue on page 4)

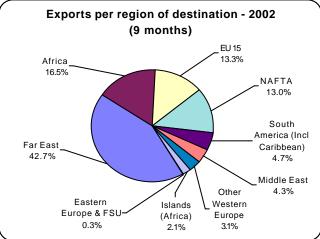
